#### a. Late Withdrawal Policy

Dr. Dej provided an overview of the proposed Late Withdrawal Policy. Members heard that the proposal outlines parameters for a late withdrawal option to assist students who have become irretrievably behind in a course. The Late Withdrawal (LWD) notation will be added to the Non-Numeric Grades and Notations chart within General Academic Regulations of the Undergraduate Calendar.

Members asked questions and discussed the proposed language. In response to a question, it was explained that students will be prohibited from re-enrolling in the withdrawn course(s) in the same term.

A member suggested that additional language be added to clarify that students may re-enroll in the courses(s) in a subsequent term. The Council discussed and agreed upon suitable language. It was noted that the proposed changes would be approved as amended at the meeting.

It was duly moved and seconded,

that Undergraduate Council approve, for recommendation to Senate, the addition of the *Late Withdrawal* section within the *General Academic Regulations* of the 2019-2020 Undergraduate Calendar, as set out in the attached and amended at the meeting.
