#### A. OPEN SESSION

#### **OPENING REMARKS**

Dr. Farrar welcomed members to the meeting and reminded Senators of Zoom protocols.

Dr. Farrar explained that as Senators will have seen, Laurentian University filed for creditor protection earlier this month citing what it called "unprecedented" challenges after a decade of financial strain. Dr. Farrar noted that this is an unusual case, and that McMaster is not in the same situation. Laurentian has suffered from declining enrolment and demographics over a number of years, largely because of its location, and has also been carrying substantial debt that the institution is unable to service. All universities borrow however Laurentian had borrowed three different times for operational items and had spent restricted reserves. Dr. Farrar explained that Alan Harrison has been appointed as a special advisor to advise on options to support Laurentian's path back to financial sustainability. There have been some indications of potential

government intervention, including the discussion of legislation being passed to allow greater oversight of every university's finances. COU, Executive Heads and Financial Officers have been working closely around this and advocating to the government. COU has prepared robust financial data on all the province's institutions and is sharing this with the Ministry to demonstrate the fiscal responsibility, and financial situation of universities across the province. COU has also prepared key messages reminding the government and others of the many reporting requirements and measures of financial accountability for universities. Dr. Farrar assured Senators that McMaster is not in danger of experiencing a similar situation as there are very few similarities between Laurentian and McMaster in terms of financial controls and processes. However, we are concerned about the potential provincial response and will continue, as a sector, to present our case to government.

An announcement was made on additional measures to be imposed on visitors arriving from overseas. Dr. Farrar explained that as a sector we are continuing to advocate for an exemption for international students from the federal requirement to quarantine at an airport hotel. Currently, McMaster has around 36 graduate students hoping to arrive within the next few weeks, as well as a number of undergraduate students. There is a detailed plan in place, and approved by Public Health, for the arrival and quarantining process for international students. This additional requirement adds a further level of complexity.

Yesterday the province announced the allocation of an additional \$7M in mental health and addiction services funding to the Ministry of Colleges and Universities. These funds will be distributed to colleges and universities through the Mental Health Services Grant at a rate of \$100K per institution and will be used to further support student mental health and related services

The University recently announced that undergraduate academic activities will be hosted remotely for the Spring/Summer/Intersession term, with a few exceptions for courses that need student access to specialized equipment. Dr. Farrar explained that a decision has not yet been made about the Fall 2021 term but as mentioned at the last meeting, the University administration is engaged in working through the scenarios and issues, with a view to making a well-informed and thoughtful announcement. The Provost, Dr. Susan Tighe, is leading a crosscampus group, supported by experts from across the University, to review data and develop scenarios that will consider ways to allow as much activity on campus as possible in September. Dr. Farrar noted that as part of our consideration of student services and supports, a McMaster Student Census and Experience Survey is currently underway. The survey launched last week and will be open until March 5, 2021. All students, including student Senators, are encouraged to participate and share their views and perspectives on current and needed services and supports.

Dr. Farrar reminded Senators that February is Black History Month and a good opportunity for us to reflect on the importance of inclusive excellence and diversity in our community, and the integral contributions of colleagues and students from the Black/African diaspora to our community. Dr. Farrar noted that he is very pleased that McMaster was able to launch the Black Excellence initiative late last year to promote and support the hiring of a cohort of Black faculty, as well as targeted programs, scholarships and supports for Black students. A program of events are underway throughout Black History Month, intended to strengthen our awareness of and

commitment to addressing racism, while also recognizing and promoting Black excellence. Senators were informed that further information is available from the Equity and Inclusion Office.

Dr. Farrar reminded Senators that the Secretariat is looking for two scrutineers for the Faculty Elections to Senate. It will take place over Zoom and will not be a large time commitment. Interested individuals were asked to please email senate@mcmaster.ca.
