A. OPEN SESSION

OPENING REMARKS

Dr. Farrar welcomed members to the meeting and wished everyone best wishes for the coming year. Senators were reminded of Zoom protocols.

Dr. Farrar explained that the Ontario government has declared a State of Emergency (effective January 12) and a Stay at Home order, which comes into effect at 12:01 a.m. tomorrow. The decisions McMaster has made during the pandemic mean that in many cases the University does not need to alter its protocols based on the new provincial rules. The details of the new regulations are being reviewed and decisions that impact any programs or services will be shared with the University community as soon as they are available. Dr. Farrar noted that the majority of University employees are already working from home with only essential work being carried out on campus. However, the number of people working from a University location increased as restrictions were eased through the summer. It is important that supervisors review any access arrangements to ensure that any employees working on campus are only doing so in exceptional

circumstances and meet the requirement that only essential workers be in the workplace. Discussions are ongoing regarding the status of on-campus research and fieldwork activities and the Vice-President (Research), Dr. Karen Mossman, will communicate any updates directly to the research community and they will also be available on the university's COVID-19 website.

Planning has begun for the 2021/22 academic year. The Provost will be leading a cross-campus group to work on this and to take a broad and holistic approach, which includes considerations for learning, teaching, research and work as we move through the next stages of the pandemic. We will keep Senators updated throughout this process. Dr. Tighe explained that more communications will be coming forward about how we will proceed forward for the return to McMaster. There will be special considerations for teaching and research. Dr. Tighe noted that they will be following Public Health guidelines closely and will be soliciting advice more broadly from the McMaster community.

Dr. Farrar explained that following the last Senate meeting, the search for the role of Senior Advisor, Equity, Inclusion and Anti-Racism in Student Affairs has been completed and will be announced imminently. As mentioned previously, this individual will lead many of the other action items arising from the review of Black student-athlete experiences in time for the start of the 2021/22 academic year.

A member asked if Dr. Tighe could explain what hybrid learning means. Dr. Tighe explained that there is no exact definition. Since campus will likely not be able to hold large lectures, and the 600-person lecture hall will not be full, they are thinking about a hybrid where the lecture hall will have a reduced number of students in attendance and other students will participate virtually. There is interest in being able to host classes on campus and they are also looking at holding smaller upper year classes in larger classrooms.
