RE: $\quad$ Primer on the McMaster University Senate

## Introduction:

McMaster operates under a bicameral system of university governance, which essentially means that there are two governing bodies, the Board of Governors and the Senate. The McMaster University Act, 1976 is an Act of the Ontario Legislature. It incorporates McMaster University, creates its two governing bodies, sets out their compositions and assigns to them their duties and legal responsibilities. When operating within their respective jurisdictions, each governing body is the final authority within the University. There is necessarily much grey area and some overlap since academic and resource matters are not always easily separated. Coordination, cooperation and understanding between the two governing bodies is essential for the smooth operation of the University.

The Board of Governors is vested with "the government, conduct, management and control of the University and of its property, revenues, business and affairs". The Board is composed of thirty-seven members, approximately $60 \%$ of whom are external to the University. The composition of the Board and its legal responsibilities are set out in sections 8 and 9 of the University Act.

The McMaster University Act and the Senate By-Laws can be found under the Home tab of the University Secretariat website.

## Powers of Senate:

The University Senate has ultimate responsibility for determining academic policy, which includes new academic programs, changes in curriculum, standards for admission to the University, academic regulations, the criteria and procedures for granting tenure and promotion to faculty members and so on. The specific powers of the Senate are described in Section 13 of the University Act:

- Appoint the Chancellor;
- Nominate, for appointment by the Board, a person for the position of President;
- Nominate for appointment by the Board, one or more Vice-Presidents, the Deans, the University Librarian, the University Registrar, and the members of the teaching staff of the University, excluding a person to be appointed for a stated period of time;
- Nominate for promotion by the Board, the members of the teaching staff of the University;
- Recommend to the Board the suspension or removal of a member of the teaching staff of the University;
- Control and regulate the system of education pursued in the University and the conduct, activities, and discipline, including suspension or expulsion, of the students thereof:
- Determine all courses of study, including standards for admission into the University and qualifications for degrees, diplomas and certificates;
- Conduct examinations and appoint examiners;
- Deal with matters arising in connection with the award of fellowships, scholarships, medals, prizes and other awards;
- Authorize the Chancellor and the Vice-Chancellor to confer the degrees of bachelor, master and doctor, including degrees in theology, and to award diplomas and certificates;
- Recommend to the Board the establishment or termination of any faculty, school, institute or department and the terms on which any institutions of higher learning may become part of or be affiliated with the University;
- Appoint an executive committee and such other committees as it may deem advisable and delegate to any such committee any of its powers;
- Make by-laws and regulations for the conduct of its affairs; and
- Make recommendations to the Board on any subject of concern to the University.


## Composition of Senate:

The composition of Senate is described in Section 12 of the University Act. Senate consists of:

- Ex officio members, including the Chancellor, the President, the Vice-Presidents, the Deans, the Principal of McMaster Divinity College and the Chair of Undergraduate Council;
- 3 members appointed by and from the Board;
- 4 members appointed by the Alumni Association;
- 12 student members, one graduate and one undergraduate from each of the six Faculties;
- 31 faculty members, elected by and representative of each of the Faculties and Divinity College.
In addition to these members, the Senate By-laws extend Observer status to a number of academic administrators and the Presidents of the faculty and various student associations. Observers do not vote or present motions and normally do not participate in debate. The Chair
may occasionally recognise an Observer who wishes to make a comment or who has particular knowledge of the material being considered.


## Confidentiality:

Much of the Senate's business is conducted in Open Session and that part of each Senate meeting may be attended by any member of the University or the wider community. Matters discussed in Open Session are not confidential and the record of Senate's Open Session proceedings is available to the general public.

The University Act provides for certain matters to be dealt with in Closed Session, i.e., "matters confidential to the University" or "matters of a personal nature concerning an individual." Items discussed in the Closed Session portion of the Senate meetings are confidential and are not to be divulged to anyone not entitled to be present. This rule applies also to the meetings of Senate committees and boards (Senate By-law 94.a).

The University is also governed by Ontario's Freedom of Information and Protection of Privacy Act (RSO 1990) (FIPPA). Despite the provisions of this Act, the substance of Closed Session discussions are normally exempt from disclosure. This Act does, however, impose on the University an even greater level of accountability with respect to the protection of confidential information about individuals.

Senate members and observers are urged to treat Closed Session discussions and materials with the necessary confidentiality, not only to protect the individuals whose names may be mentioned, but also to provide an atmosphere in which Senators and committee members may engage in frank debate on what are sometimes very sensitive issues. In this way, the dignity and authority of the Senate will not be undermined and the decisions made will more likely be based on a full and candid discussion.

## Standing Committees of Senate:

The Senate has a number of standing committees where many of the matters that come to Senate for approval are discussed in detail first. The terms of reference and the composition of these committees are described in the Senate By-laws.

The Executive Committee is authorized to act on behalf of the Senate between meetings and to deal with any matters referred to it by the President, the Senate, the Faculties or Councils, or other Senate committees. The Executive also serves as the Senate's nominating committee, making recommendations for memberships of standing committees and boards.

One of the most active of the Senate Committees is the Committee on Appointments. It is responsible for tenure policy, promotion policy, research leave policy, and policies and procedures related to academic appointments. It also reviews the tenure and promotion cases
of all faculty members and makes the recommendation to the Senate on whether tenure or promotion should be granted. This Committee nominates the memberships of selection committees for senior academic administrators and receives recommendations from those committees for approval and subsequent recommendation to the Senate and Board of Governors.

The University Planning Committee (UPC) is a joint committee of both the Board of Governors and the Senate. Many academic matters cannot be easily separated from their financial and other resource implications. With a joint Board-Senate committee, academic and resource matters can be considered together and appropriate recommendations made to either the Senate or the Board of Governors or (which is usually the case) to both. The Budget Committee is a subcommittee of UPC. The UPC presents the annual Consolidated Budget to the Senate every year for information and comment before it is sent to the Board of Governors for approval. The University Student Fees Committee is a subcommittee of UPC and recommends all revisions to tuition and supplemental fees to the Budget Committee.

The Committee on Academic Integrity makes recommendations to Senate on policy and procedures relating to academic integrity issues and on measures designed to reduce instances of academic dishonesty.

The Committee on Student Affairs is responsible for recommending to the Senate policies on non-academic aspects of student life, including University residences and student services, and on matters of student conduct and discipline.

Senate has a number of other standing committees, such as the Committee on Honorary Degrees, the Committee on University Ceremonials and Insignia, and the Committee on Bylaws.

The University has the responsibility to provide fair and equitable procedures for the lodging and hearing of complaints and grievances arising out of University regulations, policies and procedures that affect students, faculty and staff. To this end, the Senate has a number of appeal and grievance procedures.

The Board for Student Appeals is the final appeal body for all students in the University. The Board for Student Appeals also has the responsibility for reviewing the Student Appeal Procedures and for recommending changes to the Senate.

The Tenure and Promotion Appeals Nominating Committee recommends to Senate the memberships of tribunals to hear appeals of decisions related to tenure and promotion of faculty.

The Board-Senate Research Misconduct Hearings Panel, the Board-Senate Sexual Harassment/Anti-Discrimination Hearings Panel and the Faculty Discipline Board provide pools of potential members from which tribunals may be appointed to hear appeals and grievances under the relevant Senate and Board policies.

## Councils of Senate:

Two other bodies of Senate are the Graduate Council (GC) and the Undergraduate Council (UGC). Although they are subordinate bodies of Senate, they differ from the standing committees in that Senate has delegated to each of the Councils some major decision-making powers. A detailed breakdown of their memberships can be found in the Senate By-laws.

The Undergraduate Council is responsible for "regulating matters concerning undergraduate work". In practice, this means that it has the authority to approve curriculum changes recommended by Faculties, to approve minor changes in admission standards, to stipulate the conditions of award for all scholarships and prizes, to decide who will be awarded scholarships and prizes, and to make decisions on any other policies related to undergraduate work such as the academic regulations. The only matters that must be referred to the Senate for final decision are the establishment of new degree programs, closure of existing programs, substantial revisions in a Faculty's admission standards, and major changes in degree requirements. UGC is chaired by the Vice-Provost, Teaching and Learning .

The Graduate Council is similar to UGC except that it is responsible for the regulation of matters concerning graduate work. Again, Senate has delegated to GC considerable power to make decisions in the area of graduate curriculum and policy, admission standards, awards, scholarships and bursaries. The Vice-Provost and Dean of Graduate Studies is the Chair of Graduate Council.

## For Approval

I. Graduate Expectations Arising from the McMaster Vaccination Policy (Attachment) At its meeting on June $7^{\text {th }}$, Graduate Council approved the revision of the Graduate Expectations arising from the McMaster Vaccination Policy.

It is now recommended that Senate approve the establishment of the Graduate Expectations for McMaster Vaccination Policy for inclusion in the General Regulations in the Graduate Calendar 2022-2023.

## II. Faculty of Health Sciences Associate Member Policy (Attachment)

At the same meeting, Graduate Council approved the Faculty of Health Sciences Associate Member Policy.

It is now recommended that Senate approve the establishment of the Faculty of Health Sciences Associate Member Policy.

## Graduate Expectations for McMaster Vaccination Policy

As of May 1, 2022, McMaster paused its Vaccination Policy but will continue to follow emerging guidance from University experts and Public Health officials.

Should pandemic circumstances shift, the University will review the situation, which may result in the reinstatement of a mask mandate and/or the resumption of a vaccination policy. Resumption of a vaccination policy will require that access to campus be limited to those fully vaccinated against COVID19 , unless a human rights exemption is obtained.

Students will be notified directly upon resumption of a vaccination policy. Students will be expected to adhere to any academic regulations, which are developed in compliance with Public Health guidance and the University's health and safety policies, including any vaccination policy that is in effect. Any applicable deadline(s) for compliance will be clearly communicated.

Any student found to violate a mask mandate or vaccination policy that is in effect will be prohibited from accessing University property and may be subject to outcomes and/or sanctions under the Code of Student Rights and Responsibilities.

Students are expected to actively participate in classes, which will require regular attendance on campus. To minimize any potential disruption to completing their courses, all students are strongly encouraged to be fully vaccinated against COVID-19, including booster shots.

Students enrolled in clinical placements, cooperative work experiences, or other external experiential course requirements may have to comply with additional external vaccination requirements at their worksite or study site. Certain graduate programs whose students work routinely with vulnerable populations (e.g. Social Work) still require students to be vaccinated. Students in health professional programs in the Faculty of Health Sciences must complete the Health Screening Record requirements, which may include COVID-19 vaccination.

Faculty of Health Sciences Policy on Associate Membership of Thesis Supervisory Committees. Last Revised: 10 May 2022

## Background and Rationale

Permission for faculty to supervise students in thesis-based MSc and PhD programs is subject to review and approval by the Vice-Provost and Dean of Graduate Studies. This is normally delegated to the Associate Dean of the student's Faculty. Considerations for the approval of supervisory privileges in health sciences graduate programs include evidence of research qualifications, experience, and active engagement in health research, experience with graduate education, familiarity with the relevant disciplinary training culture, and the ability to commit to supervisory assignments. In all cases, primary supervisors of thesis students must have academic appointments at McMaster. In accordance with the McMaster Senate Supplementary Policy Statement, SPS 11, supervisors will normally be full-time faculty but faculty with part-time appointments may be considered, if this is strongly justified by other relevant criteria.

Permission to participate as a member of MSc and PhD supervisory committees may be granted to advisors who are not approved to serve as primary supervisors in the Faculty of Health Sciences, and this is subject to the same review and approval. Whereas it is a general requirement that thesis-based graduate students are advised and evaluated by a supervisory committee composed of McMaster faculty members, there may be instances when a student benefits from the regular and formal involvement of advisors who do not have such appointments, and may not meet the criteria for approval, more generally. For example, such advisors may be clinical or public health experts working in health care or in public health units. They may work in government, community organizations, industry, or hospital systems. The culturally appropriate conduct of research may require the participation of elders and other advisors from Indigenous communities. Restrictions on graduate research advising should allow important perspectives from outside the boundaries traditionally defined by academic status and expertise.

## Associate Membership of Thesis Supervisory Committees.

Such necessary advisors who do not meet the criteria to serve as members of the supervisory committee may be appointed as associate members of supervisory committees for MSc or PhD students. Associate members have a formal role similar in most respects to other advisory committee members. They are expected to participate regularly in supervisory committee meetings and to advise regarding the proposal, conduct, and writing of the student's research, according to the following provisions:

1. Where an associate member is appointed, the membership of the supervisory committee must otherwise meet the requirements of the Graduate Calendar, including an approved supervisor and two other approved faculty members. The size of the advisory committee, including supervisor and associate member must not exceed four members.
2. The inclusion of an associate member must be approved by the program director at the request of the student and the supervisor.
3. The role of the associate member is strictly advisory. Associate members shall not be involved in formally evaluating the student (e.g., on supervisory committee forms or at the defense), approving proposals, research plans, thesis drafts, or in decisions about adequate progress and recommendations for withdrawal.
4. The associate member should be invited to participate in all aspects of advising, including attendance at supervisor committee meetings, consultation between meetings, and feedback on written drafts.
5. A supervisory committee meeting may proceed in the absence of the associate member, where the supervisor deems this necessary to facilitate timely scheduling of meetings. The supervisory meeting form should note whether the advisor was present.
6. The associate member is a non-voting participant at the defense. The associate member does not count toward the required composition and number of members of the examining committee, as specified in the Graduate Calendar. The associate member should be invited to participate at the defense, but the defense may proceed without the participation of the associate member, if the requirements for the examining committee are otherwise met. The associate member is entitled to asks questions in the manner of other members of the examining committee. The supervisor must ensure that the Chair of the defense and, where applicable, the external examiner are aware of the role of the associate member, emphasizing that this is an approved, formal role.

On behalf of the Faculty of Health Sciences, I would like to recommend the name of the Jack Hirsh Professorship in Thrombosis be changed to the Jack Hirsh-Clive Kearon Chair in Thrombosis.

The Jack Hirsh Professorship in Thrombosis was established in 2013 through a joint funding agreement between McMaster University and Hamilton Health Sciences via the Thrombosis \& Atherosclerosis Research Institute (TaARI), a joint research institute of the University and Hamilton Health Sciences.

Dr. Clive Kearon was appointed as the inaugural professorship holder in July 2013. He held this position until June 2020 when he sadly passed away. In honour of Dr. Kearon's international leadership in the diagnosis and treatment of thromboembolic disorders, the Department of Medicine undertook a fundraising initiative to support the elevation of the Professorship to a Chair named in his memory.

To supplement the gifts received from generous donors, the Department of Medicine and TaARI committed additional matching funds so that the Jack Hirsh Professorship in Thrombosis could be converted to a fully-funded Chair known as the Jack Hirsh-Clive Kearon Chair in Thrombosis. Dr. Hirsh has been consulted on this matter and is supportive of the name change.

To coincide with this change, the terms of reference are being updated with the new name.
Please note that the current holder of the Professorship, Dr. Patricia Liaw, will continue to hold the Chair position after this conversion. Her current term is scheduled to end on June 30, 2025.

## TERMS OF REFERENCE

## Jack Hirsh Professorship in Thrombosis

## General

Transfers of funds from Hamilton Health Sciences and McMaster University have been directed to the Faculty of Health Sciences to provide support for the Jack Hirsh Professorship in Thrombosis. The research, education interests and accomplishments of the incumbent will encompass a broad and comprehensive range of issues.

## Details and Duties

The holder of the Professorship shall be an individual with sufficient research and education experience and who has demonstrated interest in and capability to implement the objectives set out below.

Specifically, the holder of the Professorship will:

- As holder of the Jack Hirsh Professorship in Thrombosis, hold an appointment in the Department of Medicine in the Faculty of Health Sciences at McMaster University.
- Be an integral part of the institutional vision towards establishing and maintaining a world-class thrombosis program which exemplifies the central values of the University and the Department of Medicine.
- Contribute significantly to the body of scholarship in the area of thrombosis, through teaching, research and/or clinical work at McMaster University.
- Undertake the normal duties of a faculty member in the Faculty of Health Sciences and the Department of Medicine, including participation in the education programs of the Department.


## Selection Process

The Committee will forward its recommendation to the Senate Committee on Appointments.

## Term

An appointment to the Jack Hirsh Professorship in Thrombosis shall be for up to five (5) years, with the understanding that renewal for additional terms is possible.

## TERMS OF REFERENCE

## Jack Hirsh-Clive Kearon Chair in Thrombosis

## General

Transfers of funds from Hamilton Health Sciences, McMaster University, and generous individual donors have been directed to the Faculty of Health Sciences to provide support for the Jack Hirsh-Clive Kearon Chair in Thrombosis. The research, education interests and accomplishments of the incumbent will encompass a broad and comprehensive range of issues.

## Details and Duties

The holder of the Chair shall be an individual with sufficient research and education experience and who has demonstrated interest in and capability to implement the objectives set out below.

Specifically, the Chairholder will:

- As holder of the Jack Hirsh-Clive Kearon Chair in Thrombosis, hold an appointment in the Department of Medicine in the Faculty of Health Sciences at McMaster University.
- Be an integral part of the institutional vision towards establishing and maintaining a world-class thrombosis program which exemplifies the central values of the University and the Department of Medicine.
- Contribute significantly to the body of scholarship in the area of thrombosis, through teaching, research and/or clinical work at McMaster University.
- Undertake the normal duties of a faculty member in the Faculty of Health Sciences and the Department of Medicine, including participation in the education programs of the Department.


## Selection Process

The Dean and Vice-President of the Faculty of Health Sciences will appoint an appropriate ad-hoc Selection Committee, which shall include, at a minimum, the Vice Dean, Research, the Chair of the Department of Medicine, and the Executive Director of the Thrombosis and Atherosclerosis Research Institute (TaARI). The Selection Committee will invite and receive nominations for the Chair and make recommendations for the appointment to the Dean and Vice-President for approval. Once approved, the Dean and VicePresident will forward the Selection Committee's recommendation to the Senate Committee on Appointments.

## Term

An appointment to the Jack Hirsh-Clive Kearon Chair in Thrombosis shall be for up to five (5) years, with the understanding that renewal for additional terms is possible based on satisfactory reviews.

## Terms of Reference

## Associate Chair, Research

## Functions:

The Associate Chair, Research (ACR) is an important leadership role and shall be a coordinator, facilitator, and promotor for research activity within the Department.

The primary objective of this role is to foster and promote excellence in research within the Department and inculcate an environment of scholarly activity. In addition to maintaining an active research program, the Associate Chair, Research will initiate the collaborative process of determining and re-examining the research mission, goals, and objectives of the department.

The Associate Chair, Research will have overall knowledge of the research activities and roles of faculty members within the Department and will provide support to all faculty in establishing new research collaborations and engagements. The role will provide additional support to the Chair in helping all faculty to meet their research goals. The Associate Chair, Research will be cognizant of research and innovation activities within the Faculty of Engineering and across the University, and of opportunities to support those activities, both administratively and financially, and to recognise and celebrate research achievements. The Associate Chair, Research will also support the Chair and Associate Chairs in planning and future growth and development.

## AcCOUNTABILITIES:

The Associate Chair, Research will primarily handle the overall planning and issues affecting research in the Department, and will support, through leadership and role modeling, an environment in which research, and innovation will occur.

## Strategic Planning

1. Assisting the faculty members in the development of grants and funding opportunities in research
2. Supporting faculty in growing their HQP complement
3. Providing guidance on research impact and evaluation

## Relationships

1. Accountable to the Chair for overall direction and operation of research-related activities
2. Develops and maintains relationships with faculty and others who are involved in research and the administration of research activities, including, but not limited to, the Associate Dean for Research, Innovation and External Relations, other Associate Chairs, Research within and outside the Faculty of Engineering, the McMaster Industry Liaison Office (MILO), the Research Office for Administration, Development and Support (ROADS), Research Finance, and the Office of the Vice President Research.

The Associate Chair, Research must meet the following criteria:

- will be a tenured faculty member at the rank of Associate Professor or Professor within the Department
- holds a full-time faculty appointment in the Department
- holds a PhD or equivalent and has a combination of teaching and research experience
- has a demonstrated record in research and a demonstrated potential for effective administration


## Reporting Requirements:

The Associate Chair, Research is accountable to the Department Chair. They will meet with the Chair and agree upon specific measurable research goals and objectives and will annually produce a short report on research outcomes and successes that will be disseminated to the Department and the Faculty.

The Associate Chair, Research will participate on a faculty-level committee chaired by the Associate Dean, Research, Innovation and External Relations.

## Rules and Procedures - Renewal or Replacement

The term of role is three (3) years, renewable once. Prior to the end of each term, the Chair will form a committee and invite applications for the position. The incumbent is eligible to apply for a second three-year term. Should the incumbent apply for a second term, the Chair, in consultation with the committee, will decide on the reappointment. The performance of the Associate Chair, Research will be reviewed annually by the Chair during the annual Record of Activities. Yearly renewal will be contingent upon agreed upon performance objectives and satisfactory performance appraisals.

## Responsibilities and Activities of the Position

The Associate Chair, Research will:

- act as a resource to the Department and will support faculty in reaching their long-term research goals
- provide an additional source of general mentorship to new faculty in the establishment of their research programs and/or careers
- foster opportunities for research experiences for all levels of HQP including undergraduate students, graduate students, residents, fellows/post-doctoral trainees and their inclusion in departmental research events
- review research proposals and provide advice and feedback
- provide support and facilitation of existing research projects, where requested
- assist in enhancing the quality of research, e.g., through advice on outreach and dissemination opportunities
- provide support and guidance on managing any external research evaluation processes which may be introduced
- work with the Associate Dean, Research, Innovation, and External Relations to raise the profile of research undertaken in the Department
- work with the Associate Dean and Office of the Vice President (Research) on issues related to commercialization, e.g., development of intellectual property, creation of start-ups, etc.
- work with the Associate Dean to identify and coordinate strategic research opportunities with industrial research partners of relevance to the Department
- be aware of research staff and infrastructure within the Department, and will be a resource to staff with respect to the renewal of said infrastructure
- advise the Chair on the status of any Departmental research deliverables, e.g., University-level reporting on Research Centres
- act as a resource to all faculty members with respect to research or other related endeavors
- be available to assist the faculty member to set goals and direct the individual to the appropriate resources to achieve these goals
- any other duties that may be assigned by the Chair


## Support/Stipend

An annual stipend of $\$ 4,000$ will be paid bi-weekly for this academic administrative role. Appropriate administrative support will be provided.
